1. **Noah Olp** – Born December 25, 1831 in York County, PA (per tombstone), died November 25, 1888 in York County, PA (per tombstone) and buried at Red Lion Cemetery in Red Lion, York County, PA

2. **Sarah Olp** – Born June 10, 1834 in York County, PA (per death certificate), died March 4, 1915 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA

3. **William Olp** – Born February 3, 1861 in York County, PA (per death certificate), died January 19, 1937 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA. He first married **Sevilla Smith** who was born January 22, 1861 in York County, PA (per tombstone), died March 22, 1881 in York County, PA (per tombstone) and buried at Adamsville United Methodist Church Cemetery in York Twp, York County, PA. He then married **Lydia Heindel** who was born January 7, 1862 in York County, PA (per death certificate), died July 5, 1901 in York County, PA (per tombstone) and buried at Red Lion Cemetery in Red Lion, York County, PA. He then married **Mary Agnes Olewiler** who was born February 23, 1880 in York County, PA (per death certificate), died April 13, 1959 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA

4. **Lewis Olp** – Born October 3, 1863 in York County, PA (per death certificate), died May 31, 1938 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA. He married **Lillie Berger** who was born March 4, 1868 in York County, PA (per death certificate), died May 20, 1939 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA.

5. **James Olp** – Born February 6, 1866 in York County, PA (per death certificate), died October 25, 1947 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA. He married **Elma Ness** who was born May 10, 1871 in York County, PA (per death certificate), died November 7, 1957 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA.

6. **Pius Olp** – Born July 29, 1868 in York County, PA (per death certificate), died March 23, 1930 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA. He married **Sue Quigley** who was born February 12, 1871 in York County, PA (per death certificate), died April 15, 1950 in York County, PA (per death certificate) and buried at Red Lion Cemetery in Red Lion, York County, PA.

Location of residence

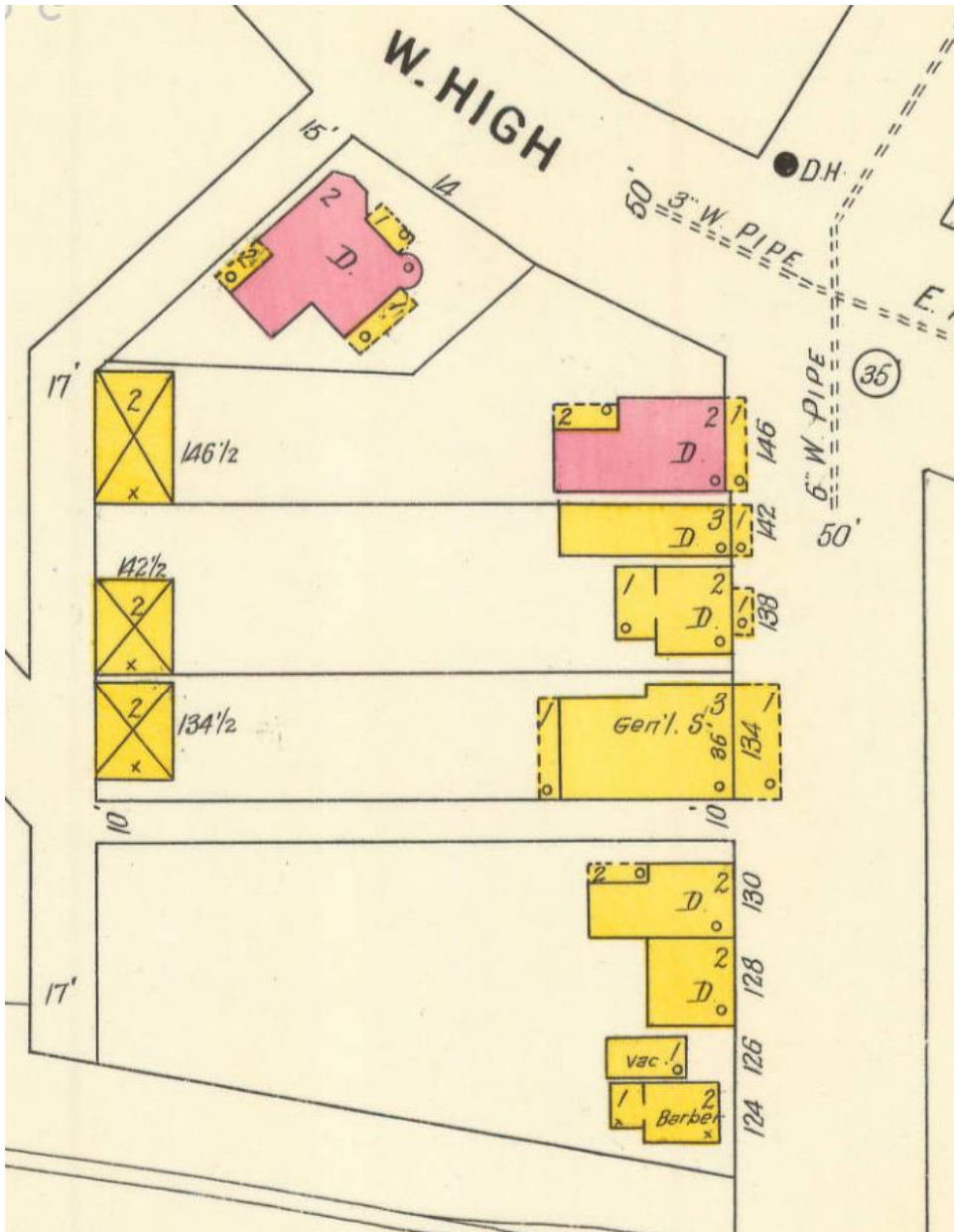
- According to the book titled *Red Lion, The First One Hundred Years*, the home at 145-147 N Main St. is thought to have been the home of Noah & Sarah Olp in 1880. I have found evidence that Sarah Olp was living at this home in the 1904 city directory, but nothing to confirm this as their residence in 1880. However, the 1885 Road Docket for the widening of N. Main St. shows that the land where 145-147 N. Main St. was built was still owned by Catherine Meyer in 1885. It is possible they rented that home from her for at least 5 years, but it does seem unlikely.

However, the order of names listed in the 1880 census suggests the Olp's lived a little further south on N. Main St. For the most part, the census taker has listed families along the first block of N. Main St. in order from the square heading north. After the home of Jacob Miller was visited at 62 N. Main St. on the south side of the railroad tracks, the next 6 households visited in order were those of (1) George Dietz, (2) William Algier, (3) Henry Paules, (4) Daniel Weaver, (5) Noah Olp and (6) Catherine Meyers.

We know that Catherine Meyer lived on the northwest corner of N. Main St. and W. High St. That would indicate the first five households would likely be located between the railroad tracks on N. Main St. and Catherine Meyer's house. Below is the 1908 Sanborn Fire Insurance Map that shows the buildings located on the west side of N. Main St. between the railroad tracks and the intersection with Main and High St.

The dwelling at the corner of W. High St. and N. Main St. was not in existence in 1880, which leaves the buildings at 128, 130, 134, 138 and 142 N Main St. as possible residences for the five households previously mentioned. Deed transactions verify that Henry Paules, the third household visited in this section, purchased what is listed as 134 N Main St. (later re-numbered 84 N Main St.) from Catherine Meyer in 1881 (this being the 3rd residence north of the railroad tracks). Coincidentally, Henry Paules's household was the 3rd household visited after Jacob Miller's household and the property at 84 N. Main St. is also the 3rd dwelling north of the railroad tracks.

Deed transactions also verify that Daniel Weaver owned the property upon which 138 N. Main St. (now 86 N. Main St.) and 142 N. Main St. (later re-numbered to 90 N. Main St. before being demolished) were built. Since Daniel Weaver's household was visited after Henry Paules's household was visited, it is likely Daniel lived at what is now 86 N. Main St, leaving 90 N. Main St. as the only household between Daniel Weaver and Catherine Meyer. This would place Noah Olp at what was listed as 142 N. Main St. (later re-numbered to 90 N. Main St.).



This residence is no longer in existence and has been torn down.

Occupation and Civic Involvement in Red Lion

- Noah is listed as a blacksmith in the 1880 census and also in the 1881, 1883, 1886 and 1887 city directories.
- William is listed as a cigar maker in the 1880 census and later records indicate he worked as foremen in a cigar factory. He initially lived at the 145-147 N. Main St. residence, before moving to what is now 13 N. Main St. and then eventually to what is now 204 W. Broadway
- Lewis is listed as a cigar maker in the 1880 census and later records indicate he worked as a laborer and a baker. According to city directories, Lewis lived on First Ave, 4th house east of Charles St, then moved to the corner of First Ave and Franklin Street before he finally moved to what is now 39 W. Gay St.

- James is listed as a farmer in the 1880 census and later records indicate he worked as a cigar maker, truck driver, laborer in a scrap factory, laborer on the railroad, and foremen in a cigar factory. James lived at what is now 213 N. Main St.
- Pius was too young to have an occupation in 1880, however he worked most of his adult life as a cigar maker or foremen in a cigar factory. He first lived with his mother at what is now 145-147 N. Main St, but eventually moved next door to what is now 141 N Main St.

- N/A
